

# COVID-19 Parental Agreement

It's really important that everyone involved in your setting is aware of their responsibility to take the recommended measures to prevent the spread of infection and keep everyone safe.

This form should be used in conjunction with the COVID-19 Risk Assessment and should be signed by childminder, parents/carers and anyone else who works in your setting. Forms can be emailed and an electronic signature obtained to make it quicker and safer to share.

## For Parents

### I/We agree to:

- ✓ Arrive and collect my child/ren promptly at the agreed times
- ✓ Spend as little time at the premises as is necessary and restrict contact with other parents
- ✓ Collect my child/ren without delay if they become unwell
- ✓ Apply for a Coronavirus test in accordance with the guidance <https://www.gov.uk/guidance/coronavirus-covid-19-getting-tested>

- ✓ Collect my child without delay if anyone in your household or a child at your setting has tested positive
- ✓ Follow the Government's self-isolation guidance if I/we or anyone in our household develops symptoms

- ✓ Notify you if my child/ren develop any symptoms while they are at home
- ✓ Not bring my child if they are unwell or if anyone in my household displays Coronavirus Symptoms
  
- ✓ Not allow my child to bring any toys or items with them unless they are essential to their well-being. I have discussed with the childminder how to manage this safely with items being cleaned on arrival
  
- ✓ The childminder passing on our families names and contact details to the NHS Test and Trace system on request, if there is a confirmed case in the setting
